#### REGULAR MEETING OF THE JERSEY VILLAGE CRIME CONTROL AND PREVENTION DISTRICT – July 21, 2015

The Board engaged in discussion concerning the budget, including the supplemental requests for budget year 2015-2016. There was considerable discussion about the transfer of the radio system to Cy-Fair. The Board also discussed the remote surveillance cameras and how these type cameras are used.

Chief Forester explained that the supplementals this year are minimal; however, next year the requests will include personnel costs no longer being covered by the traffic enforcement fund as well as several new vehicles. The Chief told the Board that the amount being set aside for vehicle replacement has not been increased in several years, and may need to be increased in next year's budget.

Discussion was then had about how the CCPD funds can be used. Some members wondered if the funds could be used to light a path around the 43 acre detention pond trail.

With no further discussion on the 2015-2016 CCPD budget, President Klussmann called the next item on the agenda.
