☑ Overview of Bond Credit Ratings

- Credit Ratings: The City of Jersey Village, Texas (the "City") maintains independent ratings from certain nationally recognized credit rating agencies, such as Moody's Investors Service and S&P Global Ratings that evaluate the City's financial strength and its ability to pay its existing bonds.
 - ✓ Moody's Investors Service: Assigns a "Aa3" credit rating to the City's General Obligation debt, defined as "Judged to be of high quality and are subject to very low credit risk."
 - ✓ **S&P Global Ratings:** Assigns a "AA+" credit rating to the City's General Obligation debt, defined as "Having a very strong capacity to meet its financial commitments. It differs from the highest-rating only to a small degree."

For comparison purposes, S&P Global Ratings assigns a credit rating of "AA" to the United States of America and a "BBB+" rating to Citigroup, Bank of America and Goldman – which is 2 rating categories below the City.






Historical Population






Full-Time Equivalent Personnel






Full-Time Equivalent Personnel Per Capita






Historical Tax Rates






Historical Total Property For Various Appraised Home Values





Composition of Total Assessed Valuation – Year 2015/16


☐ For year 2015/16, Single-Family Residential properties comprised 45.1% of the City's total assessed valuation and other property categories comprised 54.9%.




Historical Taxable Assessed Valuation and Taxable Value Per Capita






Governmental Funds* Revenues By Source


Governmental Funds* Revenues Per Capita


Governmental Funds* Expenditures By Source


Governmental Funds* Expenditures Per Capita


Enterprise Fund *(Business-Type Activities) Revenues and Expenditures




☑ Tax-Supported Debt Service By Series – Existing Bonds


Savings from City's Bond Refunding Programs




Total Bond Principal Outstanding At Fiscal Year End
